In consideration of the opportunity for my child to participate in the Document Your Place On The Planet - A Student Photography Contest ("Contest") that is sponsored by Global Oneness Project LLC ("GOP"), I agree that:

1. My child's participation is subject to the [Submission Guidelines & Rules \(the "Rules"\)](#), which I have reviewed with him or her.
2. My child will retain his or her rights to his or her entry and to his or her Photograph and Response (as defined in the Rules), but GOP, and those authorized by the GOP, may use, reproduce, adapt, modify, publish, distribute, publicly perform or display, create a derivative work, and otherwise use the Photograph and/or Response in whole or in part for any educational, promotional, or any other purpose consistent with GOP's mission, in any media now or hereafter known, without any attribution or compensation to me or my child. This includes, but is not limited to, archives, educational programs, exhibitions, fundraising, promotions (including on social media), research, and publications. This permission is irrevocable, transferrable, assignable, and perpetual. Any commercial use requires additional permissions.
3. Should my child be selected as a finalist or a winner:
 - a. His or her first name and last name, age, grade, school, and city and state in which he or she resides may be publicly announced on the Contest Website and promotional materials.
 - b. In addition to the rights granted to my child's Photograph and Response, GOP may photograph, video, and otherwise document my child's participation in any of the Contest-related programs and activities, and may use any such documentation (which may include my child's likeness, statements, and name) for any educational, promotional, or other purpose consistent with GOP's mission, in any media now known or later developed, without compensation to my child.
 - c. I will encourage my child to cooperate with GOP's reasonable requests in connection with the Contest.
 - d. My child and I shall refrain from publicly discussing his or her selection as a finalist or a winner until after GOP has made the official public announcement on its website (which is stated to be on June 1, 2020).
4. The Photographs and Responses of all finalists and honorable mentions will be displayed on GOP's website, and any other locations as determined by GOP.
5. GOP is under no obligation to use or retain my child's Photographs or Responses.
6. I release and hold harmless GOP and its officers, agents, employees, and members from any and all claims, actions and demands of any kind arising out of my child's participation in the Contest and my child's acceptance or usage of the prizes, or GOP's use of my child's Photographs, Responses, or his or her name and likeness as provided herein.
